**WHEREAS**, The Town Council of the Town of Hertford supports and encourages the initiatives of the Downtown Hertford, Inc to revitalize the Town of Hertford's downtown and businesses; and

**WHEREAS**, the Town Council acknowledges that Betsy Fest requires street closures for the safety and enjoyment of residents and visitors;

**NOW THEREFORE, BE IT ORDAINED** by the Town of Hertford Town Council pursuant to the authority granted by G.S. 20-169 that they do hereby declare a temporary road closure during the day and time set forth below on the following described portion of State Highway System route:

Dates & Times:     Saturday, April 26, 2025,   hours: 7:00 a.m. to 7:00 p.m.

Road Closure Description: Church Street from Grubb Street to Market Street  
Market Street from the Chamber to Corner of Church Street  
Not to include the intersection at Church and Market

This ordinance is to become effective when signs are erected giving notice of road closure.
